Von Wobeser helps oil services provider win Pemex contracts

Mexican firm <u>Von Wobeser y Sierra SC</u> has helped Norwegian energy company Borr Drilling's local subsidiary win two contracts from government-owned Pemex worth US\$350 million.

The contracts were awarded on 15 March.

Borr, in partnership with its Mexican counterpart Opex Perforadora, will provide Pemex with nine offshore development wells and two drilling platforms to undertake exploration in the Gulf of Mexico.

The operations are due to begin mid-2019 and last 18 months.

Borr beat seven other consortiums to land the contracts, in a public bidding process that began on 9 February.


